- Your login may only be used by you or your family members. There are no restrictions on the number of logins you can create.
- You are responsible for maintaining the security of your account and password. 405 driving School & License Testing Center cannot and will not be liable for any loss or damage from your failure to comply with this security obligation.
- You are responsible for all activity that occurs from your account.
- You agree that 405 Driving School & License Testing Center can send you booking reminders, relevant information and other marketing via phone, SMS and/or email. You can opt out of any marketing.

Cancellation Rates

Refund Policy

DRIVERS ED COURSE

Refund for the Drivers Ed course will only be given if cancellation of enrollment is made two weeks or more before the first day of class.

Drivers Ed Courses must be cancelled AT LEAST two weeks before the first day of class or a \$150 fee will be applied. Cancellation on or after the first day of class will result in automatic forfeiture of the entire payment amount.

DRIVING LESSONS & DRIVING/WRITTEN EXAMS

Driving lessons, driving exams, and permit exams must be cancelled or rescheduled AT LEAST 24 hours in advance or a \$40 fee will be applied.

Lessons and exams that are cancelled on or after the day of your scheduled drive and/or exam will result in automatic forfeiture of the entire payment amount. For Drivers Ed students this would result in the loss of one 1-hour drive voucher and would require the student to purchase one 1-hour private driving lesson to satisfy the 5 hours of drive lessons required to pass Drivers Ed.

Modifications to Services and Prices
